Dear Resident/Property Owner:

The Borough Code, §435-59, requires that the resident/property owner submit the enclosed application to Borough Hall. Initial applicants will be required to pay an application and posting fee for the sign. Upon completion and approval of the application set forth in §435-59, the Borough of Seaside Park shall issue a permit and install a sign granting the applicant a designated handicapped parking space exclusively for their use.

All persons who have requested and obtained a restricted parking space permit must apply every year for a renewal of the restricted space by January 31<sup>st</sup>. A condition of the renewal will be that the possessor of the restricted parking space must show continued possession of a valid special vehicle identification card issued by the Motor Vehicle Commission or by any other agency so designated by the State of New Jersey.
