

RAFFLE APPLICATION INFORMATION

The Legalized Games of Chance Control Commission has full authority over games of chance

Application Process

To apply for a Raffle License, the following documents must be submitted to the Borough Clerk's Office **seven (7) days** prior to the next scheduled Council meeting:

- Organization registration –must be the original certificate issued by the State of New Jersey
 - o Certificate must be current through the date of the event
- Four (4) sets of a completed application
 - Signatures & notary stamp and seal must be original on all 4 copies
 - The officer of the organization and member in charge must sign all applications before a notary
- ❖ If the application is for an off-premises 50/50, off-premises merchandise, and calendar raffles, 2 copies of the sample ticket must be submitted
 - The name on the sample ticket must match the organization name (as written) on your registration certificate
- Check or money order in the applicable fee made to the Legalized Games of Chance Control Commission
 - o List of fees is on page 2
 - Municipal fees owed are equal to that of LGCCC, but the Borough does not charge fees to non-profit organizations as determined by the IRS.
- Separate applications must be submitted for each application type
- ❖ Where the raffle equipment is to be leased, a Certificate of the Lessor shall be obtained from the raffle equipment supplier and attached to the application, such as certificate to be found on Form 13. This can be found on LGCCC website.

Note: Off-premises means that tickets are sold prior to the event.

The Approval Process

All applications must be submitted 7 days prior to the Council Meeting. If the next meeting is less than 7 days after the application is received by the Municipal Clerk, the application will be voted on at the next regular meeting of the governing body where the 7-day timeline would be fulfilled.

A resolution authorizing the application will be listed on the next Council meeting. If approved, the Borough Clerk will submit the application to LGCCC.

- ❖ A license cannot be issued until 14 calendar days have passed from the date of mailing to the LGCCC.
- ❖ After the statutory timeframe has passed, the Borough Clerk will issue the license to the applicant and provide a copy of the resolution and a copy of the application.
- ❖ The applicant is responsible to submit a Raffle Report of Operations to LGCCC no later than the 15th calendar month immediately following the month of the event.

Prohibited Prizes

The following are prohibited prizes:

- Real estate or an interest therein
- Bonds
- Shares of Stock
- Securities of evidence of indebtedness
- Weapons
- Live animals (except gift certificates redeemable for live, edible seafood)
- Foreign or domestic coins
- Tobacco products
- Motor vehicle leases or any merchandise refundable in any of the above or in money or cash

- No prize consisting of money shall be offered or awarded except:
 - A raffle conducted by drawing with the prizes equaling fifty percent of the amount received for all tickets or right to participate; a calendar raffle with the maximum prize amount not to exceed \$25,000
 - Big six wheels and horse race wheels conducted in accordance with the provisions of N.J.A.C. 13:47-8
 - An instant raffle game having maximum prize amount of \$500 for any one ticket conducted in accordance with the provisions of N.J.A.C. 13:47-8


